



The Commission on Peace Officer Standards and Training is pleased to announce a pilot presentation of a recently developed public safety dispatcher in-service training course:

The Public Safety Dispatcher's Role in Officer Safety

The goal of this course is to provide tools for incumbent public safety dispatchers to improve their skill and effectiveness in handling communications with officers in the field. Emphasis is placed upon building professional credibility and promoting trust through the dispatcher's proactive anticipation of the needs of field personnel and the informed awareness and assessment of risk indicators or danger signs. The specific objectives of the course are to provide the dispatcher with the ability to: efficiently gather and properly interpret call details in order to appropriately assess service implications and potential information needs, recognize possible threats and hazards to officers in the field, explain elements which contribute to or which could potentially compromise officer safety, and detect changes in officer behavior or demeanor which may be indicative of the need for a modified or enhanced response. The course methodology involves assessment of actual calls for service involving diverse threats and real world situations facing field officers. A variety of issues will be addressed such as the implications of complacency, tunnel vision, excited delirium, non-conventional weaponry and tactics, and the connection to the emotional wellness and survival of emergency services personnel.
