

Law Enforcement Instructor Training

Public Safety De-Escalation Tactics for Military Veterans in Crisis (PSDTMVC)

Hosted by: The San Diego Harbor Police Department

Military veterans experience a unique set of circumstances when reintegrating into society post-deployment. They can suffer physical and psychological aftereffects from traumatic experiences that can culminate in injury to themselves, their families, and public safety/law enforcement personnel.

The Upper Midwest Community Policing Institute is offering a free two-day "Public Safety De-Escalation Tactics for Military Veterans in Crisis" training with a train-the-trainer component. This course provides attendees with the knowledge, skills, and abilities to defuse crisis situations that can arise when veterans reintegrate into their communities. This course also prepares law enforcement instructors to deliver the training in their own agencies, providing the necessary course materials and optional technical assistance.

DAY 1 (prerequisite for Day 2)

This eight-hour class will train attendees on the PSDTMVC curriculum while providing an opportunity for law enforcement instructors to become familiar with the course content and observe delivery by experienced instructors in an actual classroom setting.

DAY 2

Law enforcement instructors return to attend this second 8-hour course, which will cover the following:

- Curriculum goals and learning objectives
- Instructional skills and adult-based learning techniques
- Methodologies to ensure highest level of delivery and student achievement
- Opportunities to perform an instructional "teach-back" session
- Resources for veterans to cope with challenges of reintegration

Upon completing the training, each student will receive an instructional package that includes reproducible course materials and resources: e.g., lesson plans, an instructor's manual, a participant guide, PowerPoint slides, videos, and materials to facilitate activities and class breakout sessions. Students who complete the training are also eligible to receive ongoing technical assistance as they deliver the course throughout their organizations.
